

FREELANCE TALENT SCOUT AGREEMENT

This Independent Contractor Agreement (“Agreement”) made _____, 2023

By and between:

Mountjoy Music Studio (“Company”) and
_____ (“Freelance Talent Scout”).

Whereas, Freelance Talent Scout is an independent contractor willing to provide certain skills and abilities to the Company that the Company has a demand and need.

In consideration of the mutual terms, conditions, and covenants hereinafter set forth, Company and Talent Scout agree as follows:

1. **Work Status.** The Company hereby contracts the Talent Scout as an independent contractor, and the Talent Scout hereby accepts such contract.
2. **Start Date.** The term of this Agreement shall commence on _____, 2023. Either party may, without cause, terminate this Agreement by giving 30 days written notice to the other.

3. **Services Provided.** The Company shall pay to the Talent Scout and the Talent Scout shall accept from the Company as compensation for the following services to be provided:

Contact Show Venues, Music Schools, Art Schools, Recording Studios, Performing Art Centres, Artist/Musician Agencies, Competition Sites, Event Promoters, Music Halls, Exposition, Websites, Social Media Accounts, and any and all Talent Development Centres.

Attend and Request Invitation to Attend Competitions, Recitals, Expositions, Concerts, Gigs, Events, etc.

Identify Upcoming Talents in collaboration with the Teachers, Professors, Talent Agencies, Music Stores, etc.

Organize and schedule demonstration of Talents (if any). Collect demo fees. (if any)

Collect all Talents photos, music & article and submit all content for publishing according to Publishing Requirements.

4. **Compensation.** The Company shall compensate the Talent Scout in the following manner:

FINDER’S FEE, \$100 when Talent signs talent agreement plus the first \$1000.00 earned by the Company capitalizing on the Talent.

5. **Travel Expenses.** The Talent Scout’s travel expenses shall not be reimbursed by the Company, and are considered as Talent Scout business expense, unless otherwise agreed in writing.

6. **Promotional Materials.** The Company promotional materials, including but not limited to

business cards, T-Shirts and banners, are available for FREE to Talent Scout. The shipping cost is the only expense Talent Scout shall incur if required. Other promotional materials may be approved in advance by the Company.

7. Other Business Activity. The Talent Scout may engage in other business activities provided, however, that Talent Scout shall not during the term of this Agreement solicit the Company's employees, clients, accounts, or other related business endeavours of the Company.

8. Unplanned Events. If for reasons beyond the control of the Company and Talent Scout should affect this Agreement, this Agreement shall terminate immediately. Such events include, but are not limited to, illness, incapacitation, death, or other "Acts of God".

9. Relationship Defined. Nothing in this Agreement shall indicate the Talent Scout is a partner, agent, or employee of the Company.

10. Final Agreement. It is agreed between the parties that there are no other agreements or understandings between them relating to the subject matter of this Agreement. This Agreement supersedes all prior agreements, oral or written, between the parties and is intended as a complete and exclusive statement of the agreement between the parties. No change or modification of this Agreement shall be valid unless the same be in writing and signed by the parties.

11. Legal Notice. All notices or required or permitted to be given hereunder shall be in writing and may be delivered personally or by Certified Mail – Return Receipt Requested, postage prepaid, addressed to the party's last known address listed below:
